ELECTRONIC WASTE RECYCLING WITH GOLD'N WEST SURPLUS,
INC.

RECOMMENDED ACTION:

It is recommended that the Town Council authorize the Town Manager to execute a two-year extension of the current Service Agreement for electronic waste recycling with Gold'n West Surplus, Inc.

SUMMARY:

In January 2010, the Town signed a two-year Service Agreement with Gold'n West Surplus, Inc. to purchase and dispose of electronic waste collected at the Town's Household Hazardous Waste Facility. The Town subsequently approved a two-year extension with Gold'n West in 2012 extending the service contract until January 14, 2014. The collection and disposal of electronic waste allows the Town to comply with SB 20 and SB 50 which were enacted to reduce the amount of electronic waste sent to landfills.

Gold'n West's has performed very satisfactory under the current agreement with the Town. The company's response to requests for transportation of materials and service reports are prompt and accurate. In addition, payments to the Town for electronic waste received by Gold'n West are processed in a very timely and efficient manner.

Staff recommends that the current Service Agreement with Gold'n West be extended for an additional two years, as is permitted under the terms of the existing contract.

Approval will extend the Agreement under the same terms of the original contract until January 14, 2016. A letter from the contractor expressing agreement with the proposed extension is attached.
