FEE WAIVER OR REDUCTION REQUEST FOR THE THUNDERBIRD SQUARE DANCE CLUB FOR JUNE 14, 2008.

Summary Statement:

On 8-14-01, the Town Council adopted a policy stating fees can be administratively waived for a local public agency, a utility company or service district, or a similar entity providing an essential service to the general community, whereas, all non-profit requests for fee waivers must go before the Town Council for consideration.
