CONSIDERATION OF A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF APPLE VALLEY TO ESTABLISH A POLICY FOR SELECTION OF A COUNCIL MEMBER TO SERVE AS MAYOR AND MAYOR PRO-TEMPORE

SUMMARY STATEMENT

At the Council meeting of December 9th, Mayor Pro-Tem Nassif requested that staff suggest a policy for Mayoral rotation.

Staff surveyed the twenty-three (23) incorporated cities of San Bernardino County to ascertain how Mayors are selected in our region. Thirteen of the twenty-three (23) cities surveyed elect their Mayor at-large. The remaining nine (9) cities select their Mayor amongst the Council Members on an annual basis. One of the nine cities is the City of Victorville, whose Council does not select their Mayor by rotation. Instead, Victorville's City Council selects their Mayor according to who received the highest number of votes in the election. The City of Yucaipa selects their Mayor Pro-Tem based on seniority and the highest number of votes. Although the City of Yucaipa selects their Mayor annually by members of the Council, generally the Mayor Pro-Tem rotates to Mayor.

There is no formally adopted policy in any of the nine incorporated San Bernardino County cities where the Council Members select the Mayor. Although there are seven cities that traditionally select their Mayor by rotation, because there is no adopted policy or procedure it does not always occur in that manner.

PROPOSED RESOLUTION

RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF APPLE VALLEY TO ESTABLISH A POLICY FOR SELECTION OF A COUNCIL MEMBER TO SERVE AS MAYOR AND MAYOR PRO-TEMPORE

WHEREAS, the Town Council of the Town of Apple Valley desires to establish a policy for selecting a Council member to serve in the positions of Mayor and Mayor Pro-Tempore; and

WHEREAS, it is the common practice of many municipal Councils in Southern California to select the Council member who receives the highest number of votes in the most recent election to fill the position of Mayor and the second highest number of votes to fill the position of Mayor Pro-Tempore; and

WHEREAS, the selection of a Council member to serve in the positions of Mayor and Mayor Pro-Tempore are determined by a majority vote of the Council; and

WHEREAS, the Town Council of the Town of Apple Valley has determined that it is in the best interest of governance to annually select, by majority vote of the Council, the Council candidate receiving the highest number of votes in the most recent election to serve in the position of Mayor and the Council candidate receiving the second highest number of votes to serve in the position of Mayor Pro-Tempore; and

WHEREAS, the Town Council of the Town of Apple Valley establishes the term of office for Mayor and Mayor Pro-Tempore as one year terms unless otherwise directed by the Town Council; and

WHEREAS, the Town Council of the Town of Apple Valley desires to create an orderly succession of Mayor and Mayor Pro-Tempore and that the Mayor Pro-Tempore rotate to Mayor unless otherwise determined by Council.

NOW, THEREFORE, BE IT RESOLVED THAT the Town Council of the Town of Apple Valley formally establishes a policy for the selection of a council member to serve in the positions of Mayor and Mayor Pro-Tempore, whereby, the Council member receiving the highest number of votes in the most recent election may be selected by a majority vote of the Council to serve in the position of Mayor, and the Council member receiving the second highest number of votes in the most recent election may be selected by a majority of the Council to serve in the position of Mayor Pro-Tempore, unless otherwise determined by Council.
