**PROPOSITION 84 GRANT PROGRAM, STATEWIDE PARK DEVELOPMENT AND
COMMUNITY REVITALIZATION PROGRAM**

SUMMARY STATEMENT

The Proposition 84 Parks Grant Program is a competitive grant program created by State Assembly Bill 31. The Program is being implemented through two rounds awarding a total of \$368 million to critically underserved communities throughout California. The deadline for the second round of grant application requests is July 1, 2011.

Staff reviewed the grant guidelines and determined that the proposed James Woody Improvement and Bike Park Project meets the qualifying criteria to apply for a grant. This project would expand Apple Valley's recreational opportunities beyond current offerings and would serve an unmet regional need.

Recommended Action:

That the Town Council Adopt Resolution No. 2011-23 approving the submittal of an application for Statewide Park Program grant funds.

RESOLUTION NO. 2011-23

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF APPLE VALLEY APPROVING THE APPLICATION FOR STATEWIDE PARK PROGRAM GRANT FUNDS

WHEREAS, the State Department of Parks and Recreation has been delegated the responsibility by the Legislature of the State of California for the administration of the Statewide Park Program, setting up necessary procedures governing the Application; and

WHEREAS, said procedures established by the State Department of Parks and Recreation require the applicant to certify by resolution the approval of application before submission of said application to the State; and

WHEREAS, the applicant will enter into a contract with the State of California to complete the grant scope project.

NOW, THEREFORE, BE IT RESOLVED THAT THE TOWN COUNCIL OF THE TOWN OF APPLE VALLEY hereby:

Approves the filing of an application for the **James Woody Park Improvement and Bike Park Project**, and

1. Certifies that said applicant has or will have available, prior to commencement of any work on the project included in this application, the sufficient funds to complete the project should the grant be awarded; and
2. Certifies that the applicant has or will have sufficient funds to operate and maintain the project, and
3. Certifies that the applicant has reviewed, understands and agrees to the General Provisions contained in the contract shown in the Grant Administration Guide; and
4. Delegates the authority to the Town Manager, to conduct all negotiations, sign and submit all documents, including, but not limited to applications, agreements, amendments, and payment requests, which may be necessary for the completion of the grant scope; and
5. Agrees to comply with all federal, state and local laws, ordinances, rules, regulations and guidelines.
